



## Limited Representative Warranty

**Effective Date:** August 1, 2025

### What Is This Limited Warranty and How Long Does It Last?

Vent-Rite Valve Corp. dba Skidmore “Skidmore” Pumps warrants to the original purchaser that the “Product” shall be free from defects in material and workmanship under normal use, maintenance, and service for a period of (a) 12 Months from date of install or (b) 18 months from date of shipment from our facility, **which ever date occurs first (the “Warranty Period”)**. Due to Corrosion on Cast Iron and Stainless-Steel Tanks are covered for 20 years.

This Limited Warranty is subject to the terms, conditions, and exclusions set forth below.

### Exclusions, What Does the Limited Warranty Cover?

During the Warranty Period, Skidmore agrees, at its sole discretion, to repair or replace, without charge, any Product determined by Skidmore to be defective in material or workmanship under normal use and service. Replacement may be made with new, refurbished, or functionally equivalent product(s), at the sole discretion of Skidmore. If the original Product is no longer available, a comparable product may be provided.

All replaced Products or components shall become the property of Skidmore.

### Exclusions, What Does This Limited Not Cover?

This Limited Warranty does not cover:

- Damage caused by misuse, abuse, accident, neglect, unauthorized modification, or repair;
- Damage caused by improper installation, operation, maintenance, or storage;
- Damage caused by acts of nature or God, including but not limited to lightning, flood, or earthquake;
- Normal wear and tear or cosmetic damage that does not affect functionality;
- Consumable parts or accessories, including rotating parts or gaskets, unless otherwise stated in writing;
- Motors are covered under the applicable Motor manufacturer warranty.

### Is This Limited Warranty Transferable?

This Limited Warranty applies solely to the original purchaser of the Product. It is not transferable to any other party.

### How To Make a Claim Under This Limited Warranty

To obtain warranty service, the original purchaser of the Product must contact Skidmore’s local representative within the Warranty Period.



The original purchaser must provide:

- Proof of purchase (dated sales receipt or invoice);
- Product model and serial number; and
- Description and photos of defect or failure.

Skidmore reserves the right to require the return of the defective Product for inspection prior to approving any warranty claim. Skidmore is not responsible for any cost of shipping nor the cost of removing defective or installing repaired or rebuilt products. No product under any circumstances may be returned to Skidmore unless prior consent and shipping instructions have been obtained from Skidmore service department. Product defects not covered by this warranty will be billed at our regular repair rates.

## Limitations Of Liability

This Limited Warranty is the sole exclusive remedy for any defect covered by the Limited Warranty. Skidmore's liability shall not exceed the original purchase price of the Product.

THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE LIMITED WARRANTY PROVIDED IN THIS CONTRACT. ORIGINAL PURCHASER'S SOLE AND EXCLUSIVE REMEDY IN ANY CLAIM OR ACTION AGAINST SKIDMORE, WHETHER BASED IN CONTRACT OR TORT, IS THE REPAIR OR REPLACEMENT OF THE ALLEGED DEFECT, AT SKIDMORE'S EXCLUSIVE OPTION, AND IN NO EVENT WILL SKIDMORE BE LIABLE FOR ANY SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES AND ANY SUCH DAMAGES ARE HEREBY DISCLAIMED.**
